


## Introduction of a working-day adjustment and a change in methodology for seasonal adjustments to the Labour Cost Index

According to European regulations, the Labour Cost Index have to be seasonally and working-day adjusted (SA-WDA). Up to the publication of figures for Q4 2015, the index was indeed seasonally adjusted but not working-day adjusted. Since Q1 2016, the published results have been also working-day adjusted, and this adjustment has been applied to the historical data. Adjusting for working days generated a slight revision to the whole LCI – total labour cost (a maximum of –0.1 points in the first quarters of the last three years), see *graph 1* and *table 2*. However, revisions have been more significant in mining and quarrying (B), electricity and gas production (D), water production and distribution (E) and construction (F).

Since the publication of the Q1 2016 figures, INSEE has changed the seasonal adjustment (SA) model used on the index in order to better take account of the seasonality specific to each sector. Depending on the sector, seasonality is sometimes better represented by a multiplicative rather than an additive model. This change in SA method has led to a small revision to the index across its entire scope (a maximum of 0.1 points in Q3 2015) but there have been more substantial revisions in mining and quarrying (B), electricity and gas (D), construction (F), transportation and storage (H) and financial activities (K), see *graph 3* and *table 4*.

### 1. Effect of introducing a working-day adjustment into LCI – total labour cost




