Related to the « Informations Rapides », time series in 'Excel' format and 'complementary tables' in 'PDF' format are published on the website « Insee.fr » for each publication of the accounts. All files can be found via the topic 'National accounts'.

Those series are classified into three categories (see following screenshot):

- « goods and services » for the operations by product (GDP and its components, breakdown in a demand approach, supply-use balances for large groupings);
- « activities »: breakdown by branch of the value added, employment, wages...;
- « institutional sectors » for the economic agents (households, general government, corporations...).

For each category are available:


- synthetic files, displaying from the accounts the most relevant information for a short-term economic analysis (contributions to GDP, breakdown of household income, breakdown of production cost of corporations...);
- a summary file displaying all public data; all of these series are also published *via* the 'BDM' (macro-economic database) on Insee.fr. Methodological notes are available as well.

Quarterly national accounts

National accounts - Base 2005
Last update: February 28, 2014

Quarterly accounts are a consistent set of indicators which provides a global overview of recent economic activity.
Time series of the main aggregates of quarterly national accounts can be accessed through the "Summary". They are classified into three categories:

- Goods and Services: GDP and GDP broken down in a demand approach, main operations (consumption, foreign trade, investment...) broken down by products, supply and use balances for the main aggregates
- Activities: value added, employment, wages... broken down by industries,
- Institutional Sectors: main economic agents accounts (households, corporations ...), purchasing power and households' account ratios, non financial corporations' profit share, public debt....

For each category, are available :

- synthetic files displaying from the accounts the relevant information for economic analysis
- one or two files displaying all the data available

Figures' analysis for each release can be accessed through "Publications".
