■ Job creation in competitive sector – 4th Quarter 2013

Increase in payroll employment in Q4 2013

In Q4 2013, payroll employment in principally market sectors increased by 0.1% q-o-q (+15,100 jobs), after -0.1% (-9,600) in the previous quarter. Excluding temporary work, employment fell back in Q4 2013 (-9,000 jobs).

Recover in temporary employment

Temporary employment increased this quarter : +4.6% (+24,100 jobs), after +0.6 % in Q3 2013 (+3,100 jobs).


