Turnover in the retail trade and personal services - December 2011

## In December 2011, the turnover fell in the retail trade and in the trade and repair of motor vehicles and motorcycles

Every index in this issue is in volume, seasonally and working-day adjusted.


In December 2011, the turnover declined in the retail trade, except of motor vehicles and motorcycles (-1.4 %) and in the trade and repair of motor vehicles and motorcycles (-0.9 %). It was unchanged in the household services (0.0 %) and broadly steady in accommodation and food service activities (-0.1 %).

Compared to Q3 2011 (q-o-q), the turnover of Q4 2011 slightly grew in the trade and repair of motor vehicles and motorcycles (+0.4 %). It modestly weakened in accommodation and food service activities (-0.4 %) and in the retail trade (-0.3 %). It was stable in household services (-0.1 %).

Compared to Q4 2010 (y-o-y), the turnover of Q4 2011 rose in accommodation and food services activities (+1.5 %), in the trade and repair of motor vehicles and motorcycles (+1.3 %), in the retail trade (+1.3 %), and in households services (+1.3 %).

According to our estimate, the turnover in the retail trade is expected to bounce in January 2012 (+2.0%).

#### Revisions

The SA-WDA evolution in November has been revised by -0.4 point in accommodation and food service activities. The variation, initially announced at +0.7 %, has been corrected at +0.3 %. In the same period, the SA-WDA evolution has been revised by +0.2 point in household services, in particular due to the coefficients SA-WDA's updating in the sector of hairdressing and other beauty treatment. The turnover's variation has been confirmed in the trade and repair of motor vehicles and motorcycles and in the retail trade, except of motor vehicles and motorcycles.
