

New orders received in Industry – September 2012

### In September 2012, new orders in industry decreased (-1.1%)

Warning : "New orders received in industry – December 2012" will be the last issue of new orders index in industry. New orders index has been issued since 2003 to meet a new European requirement. Eurostat intended to build a leading indicator of industrial production in the European Union. As the index obtained had not achieved its aim, Eurostat removed the requirement in 2012. In order to cut the administrative burden on business, INSEE decided to no longer investigate new orders received monthly. Monthly business surveys will continue to provide qualitative information on the state of order levels in industry.

In September 2012, new orders received in industry (except heavy transport equipment) decreased by 0.8%. They had increased in August (+0.8%).

Non-domestic new orders declined moderatly (-0.3%).

## During the last quarter, new orders decreased in industry (-2.2%)

During the last quarter (q-o-q), new orders went down in the "other manufacturing" sector (-2.1%), in the "electrical and electronic equipment" sector (-3.0%), and in the "manufacture of motor vehicles, trailers and semitrailers " sector (-1.7%).

Over the same period, non-domestic new orders declined by 0.8%.

# **Compared to last year, new orders went down** (-1.1%)

The level of new orders during the last quarter fell by 1.1% compared to last year. New orders fell dramatically in the "*electrical and electronic equipment*" sector (-10.6%) and decreased slightly in the "*other manufacturing*" sector (-0.2%). In the contrary, new orders soared in the "*manufacture of motor vehicles, trailers and semi-trailers* " sector (+5.5%). The level of nondomestic new orders rose significantly (+2.6%).
