■ Turnover in the wholesale trade and business services - January 2015


In January 2015, the turnover decreased in business support activities and in the wholesale trade

Every index in this issue is in value (tax excluded), seasonally and working day adjusted (SA-WDA). The commentary shows variations of subsections by decreasing contribution. The contribution of a subsection depends on the extent of the change and on its weight.

In January 2015, the turnover decreased in *business support activities* (-0.8%), and more slightly in the *wholesale trade, except of motor vehicles and motorcycles* (-0.2%). It also diminished in *transportation and storage* (-0.6%) and in *real estate activities* (-0.8%). Conversely, it rose again in *information and communication* (+0.6%).

Wholesale trade and business services

Slight decrease in the wholesale trade, except of motor vehicles and motorcycles

In January, the turnover of the *wholesale trade, except of motor vehicles and motorcycles* dropped slightly (-0.2%) after a slight increase in December (+0.2%). It decreased in the *wholesale on a fee or contract basis* (-2.6%) and in the *wholesales of household goods* (-0.8%) and of *food, beverages and tobacco* (-0.8%). On the contrary, it rose in *other specialised wholesale* (+1.6%), in the *wholesale of agricultural raw materials and live animals* (+4.5%) and of *information and communication equipment* (+1.9%).

The turnover of the *wholesale trade* declined over the last three months (-1.4%) and over the year (-2.0%).

Further decrease in transportation and storage

In January, the turnover of *transportation and storage* declined again (-0.6% after -0.5% in December). It decreased in *land transport and transport via pipelines* (-1.6%), in *air transport* (-0.4%) and in *postal and courier activities* (-2.8%). Conversely, it went up in *water transport* (+2.5%). It was virtually stable in *warehousing and support activities for transportation* (+0.1%).

The turnover of *transportation and storage* improved over the last three months (+1.5%) as well as over the year (+1.7%).

Decrease in real estate activities

The turnover of *real estate activities* went down in January (-0.8%) after a slight increase in December (+0.2%). It declined over the last three months of 2014 (-0.4%) and more sharply over the year (-1.3%).

Further increase in information and communication

In January, the turnover of the *information and communication* sector rose for the third month in a row (+0.6% after +1.0% in December and +0.4% in November). It improved sharply in *computer programming, consultancy and related activities* (+2.8%) and more moderately in *publishing activities* (+1.6%), in *motion picture, video and television programme production* (+1.1%) and in *programming and broadcasting activities* (+1.4%). On the contrary, it diminished in *telecommunications* (-1.7%). It remained stable in *information service activities*.

The turnover of *information and communication* increased over the last three months (+0.7%) and over the year (+0.9%).

Decrease in business support activities

The turnover of *business support activities* fell in January (-0.8%) after a near stability in December (-0.1%).

The turnover went down in *professional, scientific and technical activities* (-1.0%), especially in *activities of head offices* (-1.0%), in *architectural and engineering activities* (-0.9%) and in *legal and accounting activities* (-0.9%).

The turnover also declined in *administrative and support service activities* (-0.6%). It decreased strongly in *employment activities* (-2.7%) and in *rental and leasing activities* (-1.0%), while it improved in *office administrative, office support and other business support activities* (+1.2%).

The turnover of *business support activities* decreased slightly over the last three months (-0.3%) but increased over the year (+1.0%).

• Revisions

The change in December was revised by -0.2 point in *business support activities*. Initially calculated at +0.1%, it was revised at -0.1%.

That same month, the change was revised by -0.1 point in *transportation and storage* and by +0.1 point in *information and communication*. It remained unchanged in the *wholesale trade, except for motor vehicles and motorcycles* and in *real estate activities*.
