Monthly business survey in the building industry – December 2014

## In December 2014, the economic climate remains sluggish in the building construction industry

According to the business managers surveyed in December 2014, the situation remains sluggish in the building construction industry. The composite indicator stabilises to 89 and stays below its long-term average. The turning point indicator remains in the neutral zone.

#### Activity is still deteriorated

In December 2014, as business managers as in November have deemed that their activity has deteriorated in the recent period. They are a little more pessimistic about their expected activity. The corresponding balances remain below their long-term average.


### **Business manager are pessimistic about employment**

As business managers as in November have pointed out a fall in past and expected employment. The corresponding balances are substantially below their long-term average.

#### Order books are considered lower than normal

In December, business managers have still considered their order books lower than normal.

#### Productive capacity even less used

Production capacity even less used The productive capacity utilization rate continues to fall. At the same time, just a little more than one business manager out of five declare having difficulties increasing, against one out of three in average since 1993.


#### Prices are declared down

In December, a little more business managers than in November indicate price downturns. The corresponding balance of opinion is clearly below its long-term average.

#### Productive capacity utilization rate




#### Activity tendency in the building industry

- Expected activity (three months advanced)


#### Workforce size tendency in the building industry
