■ Turnover in industry and construction – September 2018

In September 2018, the turnover in the manufacturing industry turned down sharply (-2,3%)

The commentary shows variations of subsections by decreasing contribution to the overall evolution. The contribution of a subsection depends on the extent of the change and on its weight.

In September 2018, the turnover turned down sharply in the manufacturing industry (-2.3%) after a strong increase in August (+2.8%). It also went down in industry as a whole (-1.9% after +2.8% in August).

Export turnover dwindled sharply in September (-2.3% after +3.4% in August).

Increase over the last three months (+1.2%)


The turnover rose over the last quarter in the manufacturing industry (+1.2%) as in industry as a whole (+1.4%). Within manufacturing, the turnover grew sharply in the manufacture of transport equipment (+4.1%), in the manufacture of coke and refined petroleum products (+5.9%) and in the machinery and equipment goods (+2.1%). It was stable in the "other manufacturing" and decreased in the manufacture of food products and beverages (-0.4%).

Sharp increase compared to the previous year (+3.4%)

The turnover grew sharply compared to the same three months of the previous year in the manufacturing industry (+3.4%). It grew more sharply in industry as a whole (+4.4%) due to the strong rise in mining and quarrying, energy, water supply and waste management (+9.5%). Over this period, the turnover in the manufacture of coke and refined petroleum products surged (+31.6%). It also grew up but more moderately in "other manufacturing" (+2.3%), in the manufacture of transport equipment (+3.4%), in the machinery and equipment goods (+2.2%). It was virtually stable in the manufacture of food products and beverages (+0.1%).

How to read it: in the manufacturing, the SA-WDA variation between August and July 2018 is revised by 0.20 points: +0.03 points are due to the raw series' revision and +0.17 point to the new calculation of the SA-WDA.

Strong decrease in transport equipment (-5.2%)

The turnover in the manufacture of transport equipment went down strongly in September (-5.2% after +7.0% in August) due to the drop in the manufacture of other transport equipment (-9.8% after +16.7%) whereas it bounced back slightly in the manufacture of motor vehicles (+0.8% after -3.5%).

The turnover in the manufacture of transport equipment fell back in export sales (-3.9% after +6.3%).

Downturn in "other manufacturing" (-1.7%)

The turnover in "other manufacturing" declined in September (-1.7% after +1.8%). It turned down in other manufacturing, repair and installation of machinery and equipment (-3.2% after +2.9%), in the manufacture of basic metals and fabricated metal products, except machinery and equipment (-2.0% after +3.2%), in the manufacture of rubber and plastics products, and other non-metallic mineral products (-1.9% after 1.9%), in the manufacture of textiles, wearing apparel, leather and related products (-4.8% after +3.7%), in the chemicals and chemical products (-0.6% after +0.7%) and in the manufacture of wood and paper products; printing and reproduction of recorded media (-0.9% after +1.3%). However, it bounced back in the manufacture of basic pharmaceutical products and pharmaceutical preparations (+1.3% after -2.5%) Export sales in "other manufacturing" dwindled in September (-1.7% after +2.7%).

Downturn in machinery and equipment (-3.4%)

In September, the turnover in machinery and equipment fell back sharply (-3.4% after +3.8% in August). It decreased particularly in the manufacture of machinery and equipment n.e.c. (-4.6% after +4.2%), in the manufacture of electrical equipment (-3.6% after +2.0%) and more moderately in the manufacture of computer, electronic and optical products (-1.7% after +4.4%).

Export sales in machinery and equipment decreased (-3.8% after +3.6%).

Decline in food products and beverages (-1.8%)

The turnover in the manufacture of food products and beverages went down in September (-1.8% after +1.0%). It decreased in export (-1.0%) after a stability in August.

Increase in coke and refined petroleum products (+2.9%)

In September, the turnover in the manufacture of coke and refined petroleum products rose again (+2.9% after +2.8%).

Revisions

The variation of the turnover index in August 2018 has been highered at 2.8% instead of 2.6% in the previous publication. It has been revised upwards by 0.3 points in industry as a whole (2.8% instead of 2.5%).
